After college, Brit moved from her native Texas to Silicon Valley, where she worked at Apple on iTunes and then at Google for 4 years. In 2011, at the age of 25, she left Google and founded Brit + Co, a media and e-commerce platform for female DIYers and a creative community that connects creators, designers, chefs, and inventors. The platform has 1 million monthly users through its website and mobile app. Her spouse is Dave Morin, co-founder Path.
